A Touch of Ireland has the right to use these items for advertising and marketing on their website, social media, promotional purposes and window displays. I understand the items will be handled with care, however, A Touch of Ireland assumes no liability for lost, stolen, or damaged items that are beyond their control. A Touch of Ireland does not carry insurance for items it does not own. Please note the items listed will be tried on in the boutique. We do our best to keep items in received condition.

Please note, the consignor acknowledges that their item will be placed on consignment and tried on by potential dancers. This may result in "sample wear." However, we do our best to keep items in good condition but cannot guarantee that your item will be in the same condition as when it was consigned. You are consigning at your own discretion. At the end of the consignment period, I understand that A Touch of Ireland will NOT contact me to discuss the future of any item that remains in the store. I agree that it is MY responsibility to keep A Touch of Ireland informed of any changes to my contact information, such as mailing address, email address, phone number and legal name. If at the end of the agreement I still have an item(s) left at A Touch of Ireland and I am unable to be reached by A Touch of Ireland with the information I have provided, I understand that the items will be donated or sold by A Touch of Ireland. I agree NOT to hold A Touch of Ireland financially liable for any items that are donated or sold on my behalf after the end of the consignment period.

I understand that the item(s) listed belong to me until such a time as they have been sold or the 120 day consignment period has expired. I may at any time collect any unsold items and terminate the consignment agreement. Once my item(s) have been sold I understand that I will be contacted by A Touch of Ireland within 24 hours and will be expected to pay A Touch of Ireland the 10% commission fee within 10 days of the sale.
